Appendix 1

Responses to issues raised by the Committee of Public Accounts at the meeting of 16 February 2023

1. A breakdown, by location, of expenditure associated with IPAS accommodation (pgs. 6-7).

Please see the attached PDF (Appendix 2) "Breakdown by location average expenditure- Commercially Sensitive- not to be published". **The information contained in this document is deemed as commercially sensitive information and therefore it is requested that this information is not published.**

2. The number of hotel contracts, to house refugees, currently in place (pg. 7).

Please see the attached PDF (Appendix 3) "Number of hotel contracts for IP Accommodation purposes" which outlines the number of hotel contracts and property names which are currently in use to provide accommodation to International Protection Applicants.

3. A breakdown of each type of accommodation included within the 700 provider contracts held by the Department and a breakdown of expenditure per accommodation type (pg. 7).

Ireland has responded to the largest displacement of people on the European continent since the Second World War. Since February 2022, the Department has worked to accommodate an unprecedented volume of persons seeking refuge following the invasion of Ukraine, with over 81,000 people arriving in Ireland, including 59,000 who have sought accommodation from this Department.

Overseeing provision of accommodation on this scale during this timeframe for all those who require it remains immensely challenging. Due to the urgent need to source accommodation, the Department has contracted in excess of 47,000 beds to accommodate Beneficiaries of Temporary Protection (BOTPs) in more than 750 settings including hotels, guesthouses, B&Bs, hostels, commercial self-catering accommodation and certain other repurposed settings. In addition, more than 7,000 beneficiaries have also been accommodated in pledged accommodation properties.

The wider situation regarding provision of accommodation remains challenging. Between those fleeing the war in Ukraine and those seeking international protection, the Department is accommodating approximately 80,000 people in state-funded accommodation. Contingency



planning continues and the Department sources accommodation from multiple streams when it comes to providing shelter and security to those fleeing the war.

In addition to the above and the more than 7,200 BOTPs accommodated through the pledge process, the Department is also engaged in the implementation of rapid build homes units and is exploring the option of refurbished buildings with both the Department of Housing, Local Government and Heritage and the Local Authorities. As of 27 April, 2,677 beneficiaries have completed moves into 'Offer a Home' scheme accommodation.

The information requested has been extracted from our systems and is outlined (including locations and capacity) in tabular form below. It should be noted that the information provides an overview at a given point in time and is contingent on a number of factors that are subject to change including accommodation availability, providers in contract at any given time, configurations, transfers resulting from contracts ceasing etc. Both capacity and occupancy levels fluctuate in line with changes regarding all of the above. The table therefore provides a snapshot of accommodation on a location and capacity basis at this time.

The Department is anxious that, to the greatest extent possible, it applies a robust, consistent and value for money approach in its contracting arrangements with the range of accommodation providers.

As requested by the Committee, the estimate of expenditure on hotels (as opposed to any other category of accommodation) is approximately €37m per month at present. However, this is not a static figure – the spend going forward will be influenced by the success of DCEDIY in obtaining lower rates through renegotiation, the introduction of BOTP contributions towards their food and the availability of hotel accommodation going forward.

6. A note on the process for providers of accommodation for international protection, including the typical timeframe for when an offer of accommodation is taken up (pg. 35).

From the time an offer is received by the International Protection Procurement Service (IPPS) from an accommodation provider there are a number of steps in the process which must be followed to ensure the validity and suitability of the property to provide accommodation to International Protection Applicants (IPAs) that give value for money and meets the acceptable standards.

Potential accommodation providers are sent a proposal template to complete and return to IPPS and within that template they provide basic information such as ownership of property/insurance/fire safety information/tax clearance certificates, along with the size of property/number of bedrooms/bathrooms/common rooms/kitchens etc. and when they intend the property to be available for IPPS contract. Photographs of property can also be provided at this stage in relation to any works that may need to be carried out in advance of sign off of property as suitable.

Once the completed template is received with all of the information, the property is carefully appraised to ensure that the accommodation adheres to fire safety regulations, that the ratio of bathrooms to bedrooms is acceptable and, if there is no kitchen onsite, that the accommodation provider has detailed how they intend to cater for three meals per day per resident (many will prepare food off site and deliver to site).

If there are any concerns in relation to fire safety or any other element of the property, IPPS will have a third party inspection company (QTS Ltd) go to the property and carry out an inspection to ensure it conforms to all accommodation and safety requirements.

Once rates/terms and conditions/occupancy levels are negotiated and a start date is agreed between IPPS and the potential accommodation provider a contract is issued to the provider.

A new premises property briefing is drawn up by IPPS to include information specific to the property and local area and this is then sent to the Minister's Office for communications/briefing to take place with locally elected representatives in the area.

Once the use of the property has been cleared for use by the Minister's Office, the details are sent to IPAS for them to begin accommodating residents in the property.

All stages of this process are dependent on the availability of documentation from the provider and also if any remedial works are to be carried out in advance of the arrival of residents.

Some properties will require additional briefing material/communications to be undertaken by the Minister's Office and this can take additional time.

The Department endeavours to engage with local elected representatives as soon as possible following the agreement of terms with the Contractor/Accommodation provider.

Typical timeframes from initial offer of accommodation to arrival of residents to accommodation can vary from three or four weeks to three or four months and each offer is appraised on its own merits and suitability and viability.

8. A note on the Department's new Traveller health strategy, including any related initiatives, and any investment in key programmes and their outcomes (pg. 50).

It is important to note that while health is a key thematic heading of the National Traveller and Roma Inclusion Strategy (NTRIS), which is led by this Department, the specific health actions, which include the new health strategy for Travellers, comes under the operational responsibility of the Department of Health (and the Health Service Executive - HSE). The following material is based on briefing provided by that Department, who should be contacted if the Committee require any further information.

Detail is also given below on a number of initiatives undertaken by this Department within the context of the NTRIS that relate to Traveller health, including mental health.

Traveller health strategy

It is well known that those in the Traveller community face deep health inequalities, dying younger, having more illness and being at greater risk of substance misuse and mental health difficulties. These issues are rooted in the social determinants of health, which encompass poverty and social exclusion, poor living conditions, low education attainment, unemployment and discrimination.



There are 42 health-related actions listed under the NTRIS, including 10 actions relating to mental health and suicide among Travellers while the Programme for Government (2020) contains two health-related commitments:

- Implement a National Traveller Health Action Plan;
- Publish a Traveller and Roma Mental Health Action Plan.

The Department of Health developed and launched the National Traveller Health Action Plan (the “NTHAP”) 2022 – 2027 on 28 November, 2022. The NTHAP was informed by the findings of the All-Ireland Traveller Health Study (2010) and other official reports, including the Report of the Joint Oireachtas Committee on Key Issues Affecting the Traveller Community (2021). The development of the NTHAP involved an extensive research and engagement and consultative process with stakeholders.

There are 4 goals in the Traveller Health Action Plan, with 45 associated actions:

- GOAL 1: Strengthen the governance, monitoring and structures to support the implementation of the Action Plan.
- GOAL 2: Improve Traveller’s equality of access, participation and outcomes in mainstream health services through a human-rights based approach.
- GOAL 3: Address the Social Determinants of Traveller Health through targeted and mainstream measures.
- GOAL 4: Enhancing Travellers’ access to culturally appropriate primary health care through investment in Traveller Health units and Primary Health Care for Traveller Projects.

The Action Plan has structures in place to support the implementation of the plan, including a new NTHAP implementation Group. The HSE is working in partnership with Traveller Health Units and Primary Healthcare for Traveller Projects to develop regional implementation plans.

The NTHAP acknowledges the severe health inequalities that Travellers experience, arising from the social determinants of Traveller health, and the obstacles Travellers face in accessing healthcare services. It aims to address the specific health needs of Travellers, be they physical, mental or social well-being, using a social determinants approach. The NTHAP will assist with the realisation of Travellers’ rights in relation to health provision and the commitment and prioritisation of funding to expand and strengthen the Primary Health Care for Traveller Projects. It will also address the need for culturally safe and appropriate provision of health care for Travellers.

The annual Health Service Executive (HSE) expenditure on Traveller specific health initiatives is in the region of €10 million, including €350,000 on Traveller mental health. The HSE has recruited two dedicated Traveller Health posts to develop Traveller health policy and coordinate implementation of the NTHAP.



The Department of Health is providing additional ring-fenced funding of €1 million in 2023 to support the implementation of the plan, with a further €300,000 specifically for mental health services.

As a first step towards a comprehensive response to Traveller mental health, the National Traveller Health Action Plan contains six actions on Traveller mental health. These reflect the priority given to Traveller mental health in Sharing the Vision – A Mental Health Policy for Everyone 2020, Connecting for Life: Ireland's National Strategy to Reduce Suicide 2015-2020 (extended to 2024) and the National Traveller and Roma Inclusion Strategy 2017-2021.

Health-related initiatives funded by Department of Children, Equality, Disability, Integration and Youth

This Department funds the Traveller Mediation Service (TMS) and the Traveller Counselling Service (TCS) to deliver culturally appropriate services to the Traveller community. One of the unique attributes of TMS and TCS is that they employ Travellers as mediators and counsellors, which supports the increasing numbers of self-referrals coming from Travellers as Travellers feel those mediators and counsellors have a better understanding of the history or the underlying problems that non-Travellers might not consider relevant. This is especially important in the case of trained female Traveller mediators helping female Travellers in the community as they have a unique connection.

In 2023, additional funding is being provided to TCS to cover the cost of employing an Operations Manager and Advocacy Worker.

In addition, TMS and TCS, along with Exchange House National Travellers Service, are being supported under the Dormant Accounts Fund to work jointly on a conflict resolution project, which will address the issues of conflict and mental health in the Traveller community and provide essential family supports. The broad aim of this initiative is to address the trauma caused by inter-family violence within the Traveller community, and to provide direct supports for families trying to move away from violence.

In 2022, €180,000 in Dormant Accounts Funding was provided to this initiative which enabled the three partners to engage in foundational work to provide direct services to the Traveller communities. This involved the employment of community access workers and trauma-informed counsellors within the local community. In the initial year of this project, the demand for direct support services was high, and beyond what was initially predicted. The funding was also used to commission research on the root causes of inter-family violence and conflict. A further €180,000 is being provided to the project in 2023.
